Registration Fee

Families applying for registration for the first time are required to submit a \$450 fee upon registration. This fee may also be paid in \$75 monthly instalments for 6 months prior to the first day of school. Any **membership fees** paid during the 6 month period prior to the first day of school may be deducted from the registration fee. Subject to Board approval, this registration fee may be waived for families transferring from another Christian School.

Tuition Refund Policy

The school year covers a 10-month teaching period (September to June), while the tuition fee payments are spread over a 12-month period (September to August). If a student withdraws from the school part way through the year, the tuition fee is based on the number of months or any parts thereof. Each month or part thereof represents 10% of the total tuition fee for the year. Further, parents are requested to give three months' notice to the Board when withdrawing their family from the school. Parents of Grade 12 students are expect to make a full year tuition commitment, even when attending for only one semester. (2007-09)

The tuition fee structure for all families at RCS is listed under Tuition Fees as found above. The tuition fee is not dependent upon the number of children per family, but on the most senior grade level represented in your family. An incomplete school year is payable at 1/10 of the annual fee per month or portion thereof. ***There is no discount for having children in more than one Christian School. Tuition is already discounted due to donations and church collections. (November, 2008)***

Income Tax Receipts

All donations to RCS are tax receiptable.

You may also receive an income tax receipt as a result of tuition fee payment. Be advised that the amount recognized by *Canada Revenue Agency* as 'donation' is dependent on 'cost per pupil'. This amount changes annually due to fluctuations in student population and the number of children attending RCS from your own family.
